PARKS & RECREATION BOARD MEETING MINUTES – JUNE 15, 2023 - PAGE 1

Borgon called the meeting of the Parks and Recreation Board to order at 7:33 p.m. at the Beverly Park pavilion located at 18801 Beverly Road, Beverly Hills, MI 48025.

APPROVE AGENDA

Motion by Hausman, seconded by Ruprich, to amend the agenda to add item 5a., a presentation from Collin Nelson on a potential Eagle Scout project.

Motion passed.

Motion by Bayless, seconded by Ross, to approve the agenda as amended.

APPROVE MINUTES OF A REGULAR PARKS & RECREATION BOARD MEETING HELD MAY 18, 2023

Motion by Hausman, second by Ruprich, to approve the May 18, 2023 Parks & Recreation Board meeting minutes as submitted.

Motion passed.

PUBLIC COMMENTS

None.

UPDATE FROM EMILIO BENAVENTE, TROOP 1024, ON HIS EAGLE SCOUT PROJECT

Benavente provided an update. He built and installed 18 birdhouses in Beverly Park and Riverside Park to provide shelter for birds in the parks. He thanked the Parks Board, Village Council, and his 14 volunteers for their contributions. He also discussed the potential of having Troop 1024 do an annual cleaning and maintenance of the bird houses.

REVIEW AND CONSIDER REQUEST FROM TROOP 1024 TO PLANT A MEMORIAL TREE AT BEVERLY PARK

The Parks & Recreation Board received a request from Mike Ziegele, of Troop 1024, to plant a memorial tree with an associated plaque at Beverly Park in honor of Sarah Straith, who passed away in 2022. The Troop would fund it and would install it at the same time as the general tree planting, likely in the fall.

Hausman requested that they consider planting a native tree and stated that the Board would get Ziegele a list of potential/ acceptable trees that he can provide as options to the parents of Sarah Straith.

REVIEW AND CONSIDER REQUEST FROM COLLIN NELSON TO CONDUCT HIS EAGLE SCOUT PROJECT AT SEVERAL PARKS IN BEVERLY HILLS.

The Parks & Recreation Board received a request from Collin Nelson to install a mixture of butterfly puddling stations and butterfly houses at various parks in the village as part of his Eagle Scout Project. He distributed a handout which provided a brief overview of each option and described how they help to promote the local butterfly population. He is willing to install either option, but noted that a mixture might be ideal, to see which works best. The total project would be \$500 or less. Each single structure costs 100 - 125. He did not have a timeline yet, but was hoping to do this before winter.

Hausman suggested installing a sign instructing people not to disturb the structure. She also suggested that a guide be provided to the park rangers on how to care for and maintain the structures.

Hrydziuszko suggested that the puddling stations should not be made of ceramic material, due to the lack of durability.

The Board discussed the placement of the stations, noting Beverly Park, Riverside Park, and potentially Beverly Green as candidates. Douglas Evans was noted as not being an option, due to it being a nature preserve.

Motion by Hausman, seconded by Ruprich, to have Collin Nelson present this request to the Village Council at a later meeting date.

Motion passed.

RECAP MEMORIAL DAY PARADE AND CARNIVAL.

The Board discussed the May 29, 2023, Memorial Day Parade and Carnival. The Board agreed that the event was a huge success.

Bresnahan requested new magnets for the Grand Marshalls.

Ross noted that the band was a little far back from the main area. He also noted that the Piston's mascot and the face painter were very popular. Also, the Detroit City Football Club mascot might consider walking in the parade next time instead of driving.

Goodrich noted that holding three spots for surprise guests was a good idea.

Hrydziuszko suggested that we add a more notable Memorial element to the parade, paying a more pronounced tribute to those who served in the armed services in wartime.

Hausman agreed and suggested that they explore having a portion of the parade be dedicated to the memory and service of veterans of each war. An idea was to have a banner for each war, such as "In Memory of Vietnam," "In Memory of Korea," "In Memory of WWII," etc.

The Board agreed the event should not go beyond 2:00 p.m.

Bayless and Ross mentioned that the generators were very loud and discussed possible solutions.

RECAP JUNE CONCERT IN THE PARK.

Hrydziuszko attended the event and said that it went well and was well attended. There were about 115 people there. The band performed very well. The event went on until after 9:00 p.m. She also mentioned that the intermission was long.

Bresnahan suggested that maybe they try to have a dessert truck at the event, instead of a food truck, noting that many already have eaten dinner by the time the event starts.

There was a discussion about whether they should do more concerts and whether the concerts should be spaced out over the summer or condensed into a six-week period. The general consensus was that the current set up is logistically the best option, given the infrastructure out at Beverly Park.

DISCUSS JUNE 21, 2023, SCULPTURES IN THE PARKS SLOW ROLL/STROLL.

Hrydziuszko noted that the event was approved at the June 6 Village Council meeting. She suggested that the police car be at the end of the slow roll while they are biking, instead of at the beginning, for safety reasons.

The Board then discussed the various sculptures and who would be at which sculpture to present information to the event attendees.

Blenkhorn apologized that Clerk Rutkowski and Manager Campbell were unable to attend the meeting and thanked the Board for allowing him to attend in their stead.

Bayless thanked the Administration/Village Council for approving the purchase of a new water fountain for Beverly Park and asked for an update on the timeline of installation. Blenkhorn stated he would follow up with the Public Services Director.

Ross asked for a map of Beverly Park, to assist with landscape planning. Blenkhorn agreed to provide.

Hrydziuszko gave an update on the status of the Wendbrook property and what the possible next steps would be before Council. She encouraged everyone who is interested in this topic to provide their opinion (either for or against) to Council at upcoming meetings.

BOARD COMMENTS

Bayless thanked Hausman for all of her work organizing the parade. He suggested the Board review their tree planting and replacement strategy at Beverly Park and incorporate memorial trees into that equation. Some of the items discussed were size and density of tree planting, location of memorial trees, and whether or not they are simply planting new trees or if they should replace old and dead trees with new ones in the same spot. Bayless discussed his findings on updating the baseball fields. He received a quote for full replacement of the ball fields. The total cost to re-do the dugouts, backstop, field material, etc. was about \$1.5 million. This is the maximum cost. They could also discuss cheaper options, such as just replacing the infield material.

Bresnahan thanked Hausman for all of her work on the parade. She discussed reaching out to the Birmingham Area Cable Board for grants. The Board suggested getting a wish list going. The major items discussed were a speaker system/screen, electricity in the back of the park, and security cameras.

Hausman suggested that notable volunteers should be rewarded with a small gift, such as a tumbler cup with the Village logo on it. Ruprich is to get 24 of them. They will be distributed later in the year. Hausman noted that SPARK grant applications are due at the end of June. They will be submitting applications again this year.

Ross thanked Hausman for all of her work organizing the parade. Ross requested an update on the Buckthorn clamp that the Administration was procuring. Blenkhorn agreed to follow up with the Public Service Director.

Ruprich thanked Hausman for all of her work organizing the parade.

Goodrich thanked Hausman for all of her work organizing the parade. He stated that the Father's Day Jazz event is set and prepared.

Borgon thanked Hausman for all of her work organizing the parade. She mentioned that her dad, Bob Borgon, will no longer be doing the announcing for the event moving forward.

ADJOURNMENT

The meeting was adjourned at 9:30 p.m.

What: September is Ovarian Cancer Awareness Month

Why: For women in the US, ovarian cancer is a top 5 cause of cancer death. Yet it lacks public awareness. There is no early detection test, and as a result cases are often identified late, at stage III or stage IV. More than half of those diagnosed do not live to see a 5-year anniversary of that day.

Until better detection tests can be developed, arming women with the signs and symptoms so that they can better selfmonitor and advocate is crucial. Additionally, raising public awareness of the disease, and the funding needed to help make progress towards earlier detection and more effective treatments is paramount to better future outcomes.

How Car 1 Help? Progress is possible. Join the many other cities partnering with the Michigan Ovarian Cancer Allianz's annual Tie Michigan Teal campaign. There is no cost to the city.

Where: We will work with you! And are happy to get creative. Common ideas for teal ribbons include around city lamp posts, benches, and trees.

Would you like to participate, but only in a certain high-density area or shopping district? We can do that. Would you like teal ribbons and symptom cards at a park entrance, but not on the benches? No problem. Really, we appreciate your help and are happy to accommodate your needs. It's getting the word out that counts, and every little bit helps. Imagine, one person in your city could see that, and it could save her life.

When: September. Our volunteers will come put up ribbons and signs in the first couple days of the month, and come take them down again at the end of the month.

THE MICHICAN TEAL is a statewide campaign of the Michigan Ovarian Cancer Alliance designed to promote awareness of ovarian cancer and its symptoms. Teal is the color representing ovarian cancer. Ovarian cancer is the deadliest of the gynecologic cancers and one of the five leading cancer related deaths among women in the United States.

In 2023 approximately 19,700 women will receive a diagnosis with the disease and 13,270 women will die. Unlike other cancers, there is no early detection test for ovarian cancer.

The Tie Michigan Teal campaign consists of volunteers tying teal ribbons on lamp posts, benches and businesses in the downtown areas and distributing awareness information to local businesses to display.

The event will be held during the month of September, which has been declared National Ovarian Cancer Awareness Month. There is no cost to the city and the ribbons will be taken down at the end of the month.

She is survived by her husband Jeff and son Kaj; her parents William and Heather; sisters Lauren (Stephen) and Madeline (Eric); nieces Hazel and Nora; in-laws Michael and Lynne Fuller; in addition to many loving cousins, aunts, uncles, nieces, nephews, relatives and friends (especially the BGC).
